## MTASCD Goals and Strategic Objectives (Developed 6-18-18)

**1. Curriculum Leadership:** MTASCD is the professional network for curriculum leadership among thought leaders.

#### **Strategic Objectives with Actions:**

- 1.1 Broaden the scope of what is traditionally defined as curriculum to include SEL, whole child.
  - 1.1.1 Create a position statement to define curriculum.
  - 1.1.2 Provide access to relevant and timely curriculum resources.
- 1.2 Stay abreast of national trends to provide leadership for our stakeholders.
  - 1.2.1 MTASCD members need to stay abreast with ASCD and national trends and research in curriculum and whole child issues.
  - 1.2.2 Attend local and national conferences and workshops.
  - 1.2.3 Continue to build a relationship with national ASCD affiliate.
  - 1.2.4 Identify opportunities for reading/book study.
  - 1.2.5 Provide access to relevant and timely curriculum resources.
- **2. Professional Learning:** MTASCD promotes increased professional learning throughout the state by providing and connecting access to high quality learning opportunities for all education stakeholders.

#### Strategic Objectives with Actions:

- 2.1 Provide learning opportunities in various formats to reach rural and urban areas.
  - 2.1.1 Yearly calendar of PL opportunities.
  - 2.1.2 Access to appropriate technology.
  - 2.1.3 National, state and local cooperation to connect resources.
- 2.2 Ensure we provide access to the highest quality PL opportunities possible.
  - 2.2.1 Statewide survey of PL needs and desires for stakeholders.
  - 2.2.2 Presence at conferences and other educational gatherings to survey needs.
  - 2.2.3 Develop a process for vetting presenters.
- 2.3 Increase our networking capacity to link school district to PL opportunities planned throughout the state.
  - 2.3.1 Develop a good set of defined rules on how social media should be used by the organization.
  - 2.3.2 Designate point people to monitor ASCD sites/communication.
  - 2.3.3 Add time at ASCD board meetings to add PL opportunities to shared calendar.

**3. Advocacy:** MTASCD advocates for the promotion and assurance of excellence in Whole Child educational programming.

#### **Strategic Objectives with Actions:**

- 3.1 Support access to *health*-based programing.
  - 3.1.1 Provide information, resources.
  - 3.1.2 Raise awareness.
  - 3.1.3 Connecting community health services with schools.
- 3.2 Support the development of school-based *safety* measures.
  - 3.2.1 Disseminate information.
  - 3.2.2 Raise community awareness about the need for training (active shooter, entry protocols, etc.).
- 3.3 Provide access to best practice in education to ensure *engagement* of students and the community.
  - 3.3.1 Seek out professionals with expertise in the state.
  - 3.3.2 Be a vehicle for connecting people.
  - 3.3.3 Provide opportunities/platform for these experts to speak.
- 3.4 Enable all students to be *challenged* through the application of student-centered learning practices.
  - 3.4.1 Promote the importance of challenging all students through personalized learning.
- 3.5 Serve as a mechanism to *support* schools by creating and strengthening community-based partners.
  - 3.5.1 Create a pathway for community organizations to support.
  - 3.5.2 Develop Whole Child programming within schools through effective integration.
