# of Success for the Education Montana Students!

The 67<sup>th</sup> legislative session came to an end at 4:40 pm on Thursday, April 29 with a motion to adjourn sine die in the Senate. The advocacy work of the SAM Legislative Network 2021 created many successes for the education of Montana

students during this tumultuous legislative session. Though not all of the bills are completely through the legislature (many still awaiting action of the Governor to sign or veto), I have prepared a current update of SAM progress in the 2021 session for the review of our members (see 2021 Legislative Session SAM Update in this Bulletin). A final 2021 SAM Legislative Summary will be prepared and shared with all SAM members.

Our SAM goals – leadership involved in decisions that impact education, professional learning and services, and advocacy – clearly come to the forefront and are so very important when reflecting on the legislative session. In fact, the results of the legislative session have compelled our organization to adjust our professional learning goal to provide our members with the information they need to serve their schools and students in the best manner possible going forward. The focus of SAM and MT-PEC has turned to the development of professional learning (training PD) for our members to leverage flexibility and resources during this politically charged, COVID pandemic impacted atmosphere. Helping our school administrators develop an understanding of the flexibility and resources resulting from the 2021 legislative session actions and that of the over \$500 million of CARES Act (ESSER I), CARES II (ESSER II), and ARPA (ESSER III) funds allocated to our schools, is of highest priority this spring, summer and into the fall of 2021. You can expect to see this professional learning opportunity at the SAM Administrators Institute 2021 in July, and also at MCEL in October 2021. SAM will make this effort because we know that our members, administrators all across the state, will benefit from learning about all of the opportunities that flexibility and resources can bring to their schools, and the impact it will have on creating learning opportunities for the students served in our schools.

We are seeing the cycle – SAM members involved in decisions impacting the education of our students; the research of our SAM Leaders Professional Learning Program Collegial Learning Networks (like Transformational Learning CLN and Social Emotional Learning CLN) impacting the bills during the 2021 legislative session; and advocacy – working symbiotically to create successful opportunities for our schools and our students. My thanks to all of the SAM members who have committed their energy and time to making a difference in advocacy and professional learning research that is causing this cyclical impact of our professional association supporting quality education for each Montana student

The advocacy process for SAM begins anew in May as we prepare for Delegate Assembly 2021 (which will take place on June 10-11 in Helena with a virtual option). SAM affiliate presidents will be selecting Delegates, a call for SAM positions and resolutions to be submitted will go out to all SAM members, the SAM Delegate Assembly Steering Committee will be meeting to put together all of the details for engaging in a robust and meaningful Delegate Assembly. My thanks to all SAM members

# **Update**

On Thursday, April 29 at 4:40 pm the 67<sup>th</sup> Montana Legislature adjourned Sine Die. Week 17 of the 2021 legislative session started, as expected, with multiple floor sessions of the House and Senate with Conference Committee actions in between. The results of action on bills remaining is tracked on the SAM Followed Bills 4.29.21 list. Also, SAM Followed Bills Priority Status Report 4.29.21 will give you a look at bill status organized by SAM's advocacy priorities. At end of the session our SAM advocacy has given testimony 123 times on 63 different bills - SAM Testimony Log 2021 Legislative Session Final Updated 4.29.21. We will be preparing SAM 2021 Legislative Session Summary after the final status of all bills has been determined by signature or veto of the Governor.

Highlights of Week 17 (Apr 26-29)

The update on the SAM Priority Status Bills  $\dots$ 

### 1 SF. School Funding

- HB 663 (Ler) Support Generally revise school funding to increase GTB and lower property taxes, amended by the Senate Free Conference Committee passed the Senate 4/28 and the House on 4/29, sent to enrolling. This bill, supported by SAM and others, uses 20% of the new marijuana tax revenue to increase GTB and lower school taxes. Pending Governor signature, appears to have passed. Passed Big Win.
- HB 46 (Bedey) Support Revise
   Special Education Funding, is sent to
   enrolling having passed third reading
   in the Senate on Wednesday 4/21.
   This bill places the Special Ed
   Allowable Costs into the K-12 school
   funding formula, develops a
   methodology for calculating the costs
   and applies inflation on this funding
   formula component into the future.
   SAM supported this bill as an
   Action priority. Pending Governor
   signature, appears to have passed.
   Passed Big Win.
- HB 630 Support Appropriate CARES
   II funds, supplemental, and temporarily revise ed funding, has passed the legislature, sent to enrolling 4/26. This bill has the ESSER II funding allocation supported by SAM and MT-PEC. Pending Governor signature, appears to have passed. Passed Big Win.

   HB 632 Support Implement receipt
- HB 632 Support Implement receipt of and appropriate federal stimulus and COVID recovery funds, amended by the Senate Free Conference Committee passed the Senate 4/28 and the House on 4/29, sent to enrolling. This bill has the ESSER III funding allocation supported by SAM and MT-PEC, and the amendments in place protect schools from excluding funding for health restrictions. Pending Governor signature, appears to have passed. Passed Big Win.

# SAM Administrators Institute 2021 Launches SAM's 50th Anniversary Celebration

We are excited to launch the celebration of SAM's 50 years of service to Montana school administrators at the **SAM Administrators Institute on July 26-28** in Helena! Over the past 50 years, SAM members have worked to build a strong, relevant, effective organization whose members continue to strive to accomplish SAM's Strategic Plan Goals of Leadership Involved in Decisions that Impact Education, Advocacy, and Professional Learning and Services.

We welcome everyone to participate in the launch of the 50th Anniversary celebration by attending the SAM Administrators Institute: *Reimagining the Future with Strategies of Hope Moving Forward.* Focus Zone Sessions for the conference are:

Social Emotional & Mental Health,

HB 2 (Jones) General appropriations act, amended by the Senate Free Conference Committee passed the Senate 4/28 and the House on 4/29 with much debate and 65-33 3<sup>rd</sup> reading vote, sent to enrolling. HB 2 education portions of the appropriations bill remain in place. Pending Governor signature, appears to have passed. Passed.

#### 2 PP. Privatization with Public Funds

- HB 279 (Berglee) Oppose Revise laws related to tax credit scholarship and innovative education programs, passed the legislature, sent to enrolling 4/27. SAMLN21 Call to Action #8 was initiated to oppose this bill in the Senate. This bill extends the tax credit for individuals to invest in funding individual student attendance in private (and private religious) schools as well as public schools. HB 279 increases the individual tax credit from \$150 to \$200,000, and also eliminates the accountability measures (like testing and verifying progress made by students) from the Student Scholarship Organizations that provide the scholarships for students attending private schools. Amendment 2 added to the bill does clarify that donations to the public side of the bill can be targeted to go to a school district for support of innovative programs (clearly defined as the criteria passed in HB 246 much flexibility for public schools), this was a positive addition to the bill. Amendment 4 added to the bill added 15 pages to the 11 page bill with language to allow the Governor's budget Director to annually review the tax credit status to ensure that implementation will not trigger federal ARPA funding to be withheld from Montana. The fact that this concern exists (sacrificing \$1.2 billion in funding to Montana) is an indication of how much risk this bill puts our state in. Pending Governor signature, appears to have passed. Passed - Big Challenge.
- HB 329 (Vinton) Oppose Establish students with special needs savings account, was tabled in Senate **Education and Cultural Resources** Committee on 4/7. HB 329 would create a special needs education savings account program, whereby parents of a qualified special education student can sign a contract to use the funds to attend a nonpublic school program for services. SAMLN21 Call to Action #5, #6 and #7 were implemented to oppose this bill because this bill blasted off the table and onto the Senate floor at any time from now until the end of the legislative session. A blast motion happened on 4/23 during the 1:00 pm Senate floor session with the vote failing 15-34! Thank you to all administrators who have working on these Calls to Action. No further blast motions occurred up to Sine Die, bill failed to pass the legislature. Failed - Big Win.

# SAM Youth Endowment Gifts Disbursed

grant program, is sent to enrolling having passed third reading in the Senate on 4/23. SAM and education partners support this bill for its innovative strategies to create grow your own programs across the state. Pending Governor signature, appears to have passed. Passed – Big Win.

### 5 IT. Infrastructure and Technology

- HB 181 (Zolnikov) Support
  Reauthorizing the e-rate broadband
  program, is sent to enrolling having
  passed the Senate 49-0 on Tuesday,
  4/20. SAM and education partners
  support this bill to support
  broadband expansion for our schools
  using e-rate and match from the
  state. Pending Governor signature,
  appears to have passed. Passed –
  Big Win.
- SB 297 (Ellsworth) Support ConnectMT Act to establish broadband deployment, is sent to enrolling having passed the Senate on 4/27. This bill has coordinating language to merge the federal funds and state funds for developing the broadband access planning for the State going forward. SAM supported the bill as amended. Pending Governor signature, appears to have passed. Passed Big Win.

### 6 EP. Education Policy

- SB 400 (Manzella) Oppose Restrict governmental entities from interfering with parental rights, is sent to enrolling having passed Senate on 4/27. This bill is nearly identical to SB 259, with minor changes articulating a standard of review that already exists through common-law doctrine on fundamental rights and the addition of a filing fee, to allow for a transmittal deadline. The bill would allow a cause of action against any party, including a school district, who a parent deems as interfering with their rights. This will, in turn, cause unnecessary expense for school districts and taxpayers in addressing these issue. MT-PEC has stood opposed to this bill. Pending Governor signature, appears to have passed. **Passed - Big Challenge.**
- HB 206 (Bedey) Support Revise education laws related to tuition and in-state treatment, is transmitted to the Governor having passed the Senate on Thursday 4/15. This bill modifies the sections of law that establish the rate to be paid for education services for children at a children's psychiatric hospital (CPH) or residential treatment program (RTF) and the tuition rates paid by the district of residence for a child placed in another district. Pending Governor signature, appears to have passed. Passed Big Win.
- HB 671 (Bedey) Implement provisions of HB2 Section E education, is sent to enrolling having passed the House on 4/26. The amendment passed contains the language that resolves the challenges that put at risk the CSCT Medicaid reimbursement programs. The amendment promoted by the MT-PEC partners is now in the bill. Pending Governor signature, appears to have passed. Passed Big Win.

The SAM Board of Directors recently awarded \$9750 to assist Montana students through funds allocated through the SAM Youth Endowment. Eleven students were each gifted funds to assist with their specific financial needs. Since 2010, the SAM Youth Endowment has disbursed more than \$76,000 to Montana youth in need.

The purpose of the SAM Youth Endowment is to make a positive impact on the youth of Montana by providing financial assistance to benefit children's health, welfare, and/or education. Each of the six affiliates under the SAM umbrella contributes to the SAM Youth Endowment each year. Contributions are also received through donations and memorials.

The SAM Board of Directors first discussed the endowment possibilities in 1998. At that time the Board felt it was important for SAM to be involved financially with a cause that affected the youth of Montana. The discussion led to the establishment of an endowment that would contribute to different charities making a positive impact on the youth of Montana. In the Spring of 2001, the Board approved the SAM Youth Endowment Fund Guidelines for Assistance.

Thank you, SAM members, for submitting nominations for students in need. The SAM Youth Endowment is an excellent way for you to give back to the students you work with each day. The desire to assist Montana youth in helping to ease their specific financial need speaks to the integrity of each of you who are dedicated to creating education excellence for Montana students.

### 7 RT. Revenue and Taxation

 SB 388 (Hertz) Oppose Provide for infrastructure through tax increment financing, is sent to enrolling having passed the Senate as amended on 4/26. This bill expands the purposes for which tax increment financing can be used to fund infrastructure and would only exempt half the state school equalization mills. SAM and MT-PEC partners have stood in opposition to this bill and requested amendments that would exclude all of the equalization mills and clarify that school districts have the authority to exclude their current levies from the TIF. The amendments approved by the House Appropriations Committee do help clarify how a school district can confer with the county commission to exclude current levies from the TIF. The amendment to exclude the state equalization mills failed in the committee. Pending Governor signature, appears to have passed. Passed - Big Challenge.

# 9 SP. State Policy

HB 435 (Mercer) Generally revise civil liability laws for government, is sent to enrolling having passed the Senate on 4/29 with the 2/3 vote required on 3<sup>rd</sup> reading after having failed and then blasted back to the floor. This bill provides civil liability protection for government entities (school districts are included) from actions like those related to health and implementation of COVID-19 guidelines. SAM has monitored this bill but do support the concept because if it passes it would protect schools in addition to what currently exists in law for protections. This bill will require 2/3 majority vote of the Senate. Passed - Big Win.

SAM advocacy tracked 364 bill drafts with 190 of those bills introduced. Check out the SAM Followed Bills 4.29.21 and SAM Followed Bills Priority Status Report 4.29.21 to see the status of SAM Followed Bills awaiting final action by the Governor. At end of the session our SAM advocacy has given testimony 123 times on 63 different bills – SAM Testimony Log 2021 Legislative Session Final Updated 4.29.21


