Here are some suggestions if you are considering a resolution for submission to assist SAM, the Delegates and the full membership:

- ✓ State the action you are calling on SAM to address
- ✓ If it is not readily apparent from the wording of the resolution, provide any citations to legal statutes or rules that the resolution is proposing to amend (if you know)
- ✓ Provide some background information or rationale that explains your perspective on why the resolution should be considered by Delegate Assembly and the Membership
- ✓ Send the Resolution request via email to Kirk Miller, SAM Executive Director at <a href="mailto:samkm@sammt.org">samkm@sammt.org</a> by Friday, June 2, 2017 so it can be prepared for the Delegate Assembly Caucus scheduled for the afternoon of June 15. A copy should also be sent to your Affiliate President and the Affiliate Delegate Assembly Steering Committee Member as well.

Thanks for your review and effort to help SAM prepare our Advocacy package prior to the 2019 Legislative Session.
