# HB 390 and Broadband for Montana Schools What you need to know

- The State of Montana is investing in broadband for your students:
  - \$2M in state matching funds for your schools available
  - \$250,000 is available for E-rate consulting to assist your schools as they apply for funding this year
- Funding only exists this year and next year
- Funding available for connecting your school to fiber and the connections within your school

#### **District Profile**

- Rural district in Lolo Valley
- 1 school serving about 40 students







#### Woodman School

#### Reasons to upgrade

- ▶ 10 computers in computer lab, 8 additional Chromebooks to engage students in technology at all grade levels – not all can be online at the same time.
- Montana Digital Academy is available to introduce middle school students to foreign languages – however, students must take turns logging on to the site.
- Exams must be taken from another school 30 minutes out of the valley making a 30 minute exam a 90 minute process.

Our goal: Upgrade our Internet access at an affordable price to allow all students the opportunity to take advantage of technology in the classroom.



#### Woodman School

#### Solution

- Work continues to ensure that the infrastructure is built for the students and schools.

#### Montana School Broadband Project Year Three Update

Continued partnership between Governor Steve Bullock's Office, Department of Commerce, Office of Public Instruction, SAM, and EducationSuperHighway.

#### **Progress:**

- 94% of school districts representing 96,588 students meet the minimum connectivity goal of 100 kbps per student.
- 75% of schools have the fiber connections they need to keep up with growing bandwidth demand from students and teachers.
- \$9.7M of E-rate funding is left to support Wi-Fi network upgrades.
