 - Tim Miller:
 - Prior Written Notice (PWN) ~ see handout, will send electronic version
 - Has to go out to all parents anytime there is an initiation or a change
 - What do you have to do in writing? What is being proposed, evaluation it is based on, relevant factors. Have to write in 7 items, parental rights is already embedded.
 - IEP: (placement decisions, FAPE). Reason for PWN is to inform parent of all changes prior to change or implementation. Wait until after the IEP meeting even if you do fill in the PWN right after the meeting, but is not a collaborative parent process. Still can't have parents sign because not a reasonable timeframe for parents to review the IEP. Tim recommends to wait a little bit after the meeting. Parents sign that they were at the meeting, but not that they agree with the plan yet. If parents don't get it back by renewal date, stay put with old IEP. Technically in compliance because meeting was held.
 - Initial IEP, if parents do not agree schools need to stop moving towards services.
 - Need to start earlier, may need to be more structured with Excel spreadsheets, will need some help.
 - Suggestion is to not do back to back ER and IEP meetings
 - If parent is adamant about signing, you can make the exception!
 - Another exception is with an amendment
